It is hereby agreed to between the two parties that:

- 1. The Contractor shall register at the respective division.

Where there is breakage/damage to any materials due to negligence during execution of works and/or loss of any materials issued on to him due to theft the contractor shall be solely responsible for making good the loss sustained by the corporation which shall be recoverable by way of deduction of the loss as assessed by the corporation from the amount payable to the contractor and/or by.

- 10. The contractor shall return all the un-used materials to the Engineer-in-charge of the works at his Head Quarters in good usable original condition within a week after completion of the work and before submitting the bill. If any of the materials are found damaged/ maturated cut in to pieces/not returned etc. the cost of such materials shall be recovered out of the bills/SD of the contractor and/or any by suit.
- 11. In the event of the contractor not adhering to the schedule of progress stipulated inclause-9 above in spite of materials having been supplied on time penalty shall be imposed at 0.5 per week delay in part thereof on the value of incomplete labour portion of week subject to the maximum of 10%.
- 12. In the case of work is not completed in all respects within the period as specified inclause-9 above the same shall be completed by the corporation at its full discretion and the extra cost involved in the form of labour, transpiration supervision etc. shall be recovered from the contractor out of his bill/deposit and or from the bills payable/deposit in other divisions. The divisions of the Executive Engineer(Ele), of the divisions final and binding.
- 13. In the case of work is not commenced within one week from the date of handing over of the materials and for breach of any conditions of this agreement amount paid as security deposit if any will be for feted and the incomplete work will be got done through the another contractor or departmentally at the risk and cost of the contractor cost of the contractor and at the description of the Executive Engineer Ele of the division concerned. The cost incurred by the corporation shall be recovered assign clause 12 above.
- 14. On completion of the works assigned the Engineer-in-charge will be arrange make the measurements and issue a certificate of completion.
- 15. Measurements will be taken only once after the set of works are completed.



- 16. The corporation shall not be liable to pay any claims to the contractor towards idle labour if any which he may suffer for any reasons whatsoever.
- 17. In case any dispute arising out of this contract the contractor may appeal to the jurisdictional Chief Engineer any may hear and decide the dispute within one month from the date of appeal.
- 18. In the event of any dispute the same is deemed to have arisen within the jurisdictional of the court situated at the Head Quarters of the Executive Engineer Ele of the Division concerned.
